HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB21-1111 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and  
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, **add** 24-37.5-118 as  
4 follows:

5 **24-37.5-118. Study of personally identifiable information -**  
6 **authority of chief information officer - report to joint technology**  
7 **committee - definitions - repeal.** (1) THE CHIEF INFORMATION OFFICER  
8 SHALL CONVENE AN ADVISORY GROUP DURING THE 2022 INTERIM TO  
9 STUDY WHERE PERSONALLY IDENTIFIABLE INFORMATION IS STORED BY  
10 STATE AGENCIES THROUGHOUT COLORADO AND TO DETERMINE THE COSTS  
11 AND PROCESSES NECESSARY TO CENTRALIZE THE STORAGE AND  
12 PROTECTION OF PERSONALLY IDENTIFIABLE INFORMATION.

13 (2) THE ADVISORY GROUP CONSISTS OF:

14 (a) THE MEMBERS OF THE GOVERNMENT DATA ADVISORY BOARD  
15 CREATED IN SECTION 24-37.5-703;

16 (b) ONE MEMBER WHO REPRESENTS THE ATTORNEY GENERAL'S  
17 OFFICE, APPOINTED BY THE ATTORNEY GENERAL; AND

18 (c) ANY NUMBER OF MEMBERS WHO ARE PERSONALLY  
19 IDENTIFIABLE INFORMATION EXPERTS SELECTED AND APPOINTED BY THE  
20 CHIEF INFORMATION OFFICER.

21 (3) ON OR BEFORE JANUARY 1, 2023, THE ADVISORY GROUP SHALL  
22 PRESENT TO THE JOINT TECHNOLOGY COMMITTEE A SUMMARY OF THE  
23 ADVISORY GROUP'S FINDINGS, INCLUDING, IF APPROPRIATE, PROPOSALS  
24 FOR LEGISLATION.

25 (4) AS USED IN THIS SECTION:

26 (a) "PERSONALLY IDENTIFIABLE INFORMATION" MEANS  
27 INFORMATION THAT MAY BE USED, ALONG OR IN CONJUNCTION WITH ANY  
28 OTHER INFORMATION, TO IDENTIFY A SPECIFIC INDIVIDUAL, INCLUDING BUT  
29 NOT LIMITED TO A NAME; A DATE OF BIRTH; A PLACE OF BIRTH; A SOCIAL  
30 SECURITY NUMBER OR TAX IDENTIFICATION NUMBER; A PASSWORD OR  
31 PASS CODE; AN OFFICIAL GOVERNMENT-ISSUED DRIVER'S LICENSE OR  
32 IDENTIFICATION CARD NUMBER; INFORMATION CONTAINED IN AN  
33 EMPLOYMENT AUTHORIZATION DOCUMENT; INFORMATION CONTAINED IN  
34 A PERMANENT RESIDENT CARD; VEHICLE REGISTRATION INFORMATION; A  
35 LICENSE PLATE NUMBER; A PHOTOGRAPH, ELECTRONICALLY STORED  
36 PHOTOGRAPH, OR DIGITIZED IMAGE; A FINGERPRINT; A RECORD OF A  
37 PHYSICAL FEATURE, A PHYSICAL CHARACTERISTIC, A BEHAVIORAL  
38 CHARACTERISTIC, OR HANDWRITING; A GOVERNMENT PASSPORT NUMBER;  
39 A HEALTH INSURANCE IDENTIFICATION NUMBER; AN EMPLOYER, STUDENT,  
40 OR MILITARY IDENTIFICATION NUMBER; A FINANCIAL TRANSACTION

1 DEVICE; A SCHOOL OR EDUCATIONAL INSTITUTION ATTENDED; A SOURCE  
2 OF INCOME; MEDICAL INFORMATION; BIOMETRIC DATA; FINANCIAL AND  
3 TAX RECORDS; HOME OR WORK ADDRESSES OR OTHER CONTACT  
4 INFORMATION; FAMILY OR EMERGENCY CONTACT INFORMATION; STATUS  
5 AS A RECIPIENT OF PUBLIC ASSISTANCE OR AS A CRIME VICTIM; RACE;  
6 ETHNICITY; NATIONAL ORIGIN; IMMIGRATION OR CITIZENSHIP STATUS;  
7 SEXUAL ORIENTATION; GENDER IDENTITY; PHYSICAL DISABILITY;  
8 INTELLECTUAL AND DEVELOPMENTAL DISABILITY; OR RELIGION.

9 (b) "STATE AGENCY" MEANS ANY DEPARTMENT, COMMISSION,  
10 COUNCIL, BOARD, BUREAU, COMMITTEE, INSTITUTION OF HIGHER  
11 EDUCATION, AGENCY, OR OTHER GOVERNMENTAL UNIT OF THE EXECUTIVE,  
12 JUDICIAL, OR LEGISLATIVE BRANCH OF STATE GOVERNMENT.

13 (5) THIS SECTION IS REPEALED, EFFECTIVE JANUARY 1, 2024.

14 **SECTION 2. Act subject to petition - effective date.** This act  
15 takes effect at 12:01 a.m. on the day following the expiration of the  
16 ninety-day period after final adjournment of the general assembly; except  
17 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
18 of the state constitution against this act or an item, section, or part of this  
19 act within such period, then the act, item, section, or part will not take  
20 effect unless approved by the people at the general election to be held in  
21 November 2022 and, in such case, will take effect on the date of the  
22 official declaration of the vote thereon by the governor."
