## SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture, Natural Resources, & Energy.SCR17-002 be amended as follows:

- 1 Amend printed resolution, page 3, line 19, after "**housing**" insert "**and**  
2 **permanent supportive housing**".
- 3 Page 3, line 22, strike "HOUSING" and substitute "HOUSING, INCLUDING  
4 MANUFACTURED AND MOBILE HOMES,".
- 5 Page 3, strike lines 24 and substitute "MEDIAN INCOME.".
- 6 Page 4, strike lines 1 and 2.
- 7 Page 4, strike lines 3 through 7 and substitute:
- 8           (b) "COST-BURDENED HOUSEHOLD" MEANS A HOUSEHOLD THAT  
9 SPENDS MORE THAN THIRTY PERCENT OF ITS INCOME ON HOUSING COSTS,  
10 WHICH AMOUNT INCLUDES SUCH ITEMS AS RENT; UTILITIES AND SERVICES,  
11 EXCLUDING TELEPHONE, TELEVISION, AND INTERNET SERVICES;  
12 MORTGAGE PAYMENTS REFLECTING THE SUM OF MONTHLY PRINCIPAL,  
13 INTEREST, TAXES, AND INSURANCE; AND HOMEOWNERS' ASSOCIATION  
14 DUES.".
- 15 Page 4, after line 18 insert:
- 16           (f) "MANUFACTURED HOME" HAS THE SAME MEANING AS DEFINED  
17 IN SECTION 38-29-102 (6), OR ANY SUCCESSOR SECTION.
- 18           (g) "MOBILE HOME" HAS THE SAME MEANING AS DEFINED IN  
19 SECTION 38-12-201.5 (2), OR ANY SUCCESSOR SECTION.
- 20           (h) "MOBILE HOME PARK" HAS THE SAME MEANING AS DEFINED IN  
21 SECTION 38-12-201.5 (3), OR ANY SUCCESSOR SECTION.
- 22           (i) "PERMANENT SUPPORTIVE HOUSING" MEANS DECENT, SAFE,  
23 AFFORDABLE, COMMUNITY-BASED HOUSING FOR LOW-INCOME PERSONS  
24 WITH DISABLING HEALTH CONDITIONS OR SPECIAL NEEDS WHO ARE  
25 UNSTABLY HOUSED OR EXPERIENCING HOMELESSNESS. "PERMANENT  
26 SUPPORTIVE HOUSING" IS LINKED WITH HEALTH CARE AND SUPPORTIVE  
27 SERVICES THAT ASSIST INDIVIDUALS AND FAMILIES TO LEAD MORE STABLE  
28 LIVES.
- 29           (j) "SEVERELY COST-BURDENED HOUSEHOLD" MEANS A  
30 HOUSEHOLD THAT SPENDS MORE THAN FIFTY PERCENT OF ITS INCOME ON  
31 HOUSING COSTS, WHICH AMOUNT INCLUDES SUCH ITEMS AS RENT;



1 UTILITIES AND SERVICES, EXCLUDING TELEPHONE, TELEVISION, AND  
2 INTERNET SERVICES; MORTGAGE PAYMENTS REFLECTING THE SUM OF  
3 MONTHLY PRINCIPAL, INTEREST, TAXES, AND INSURANCE; AND  
4 HOMEOWNERS' ASSOCIATION DUES."

5 Reletter succeeding paragraph accordingly.

6 Page 6, strike line 14 and substitute "HOME OWNERSHIP;"

7 Page 6, line 18, after "COST-BURDENED" insert "OR SEVERELY  
8 COST-BURDENED".

9 Page 6, strike line 20 and substitute "HOUSING AND PERMANENT  
10 SUPPORTIVE HOUSING; OR

11 (c) THE REHABILITATION OR REPAIR OF MOBILE HOME PARK  
12 INFRASTRUCTURE."

13 Page 6, line 27, after "HOUSING" insert "AND PERMANENT SUPPORTIVE  
14 HOUSING".

15 Page 7, strike lines 1 through 3 and substitute "PROJECTS THAT PROVIDE  
16 HOUSING FOR COST-BURDENED AND SEVERELY COST-BURDENED  
17 HOUSEHOLDS."

18 Page 7, line 27, after "HOUSING" insert "OR PERMANENT SUPPORTIVE  
19 HOUSING".
