SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB20-101 be amended as follows:

1 Amend printed bill, page 2, line 4, strike "WITHIN" and substitute
2 "EXCEPT AS PROVIDED IN SUBSECTION (4)(c) OF THIS SECTION, WITHIN".

3 Page 3, after line 6 insert:

4 "(c) THIS SUBSECTION (4) DOES NOT APPLY TO COMPLAINTS
5 CONCERNING THE COMMERCIAL APPLICATION OF PESTICIDES ON A
6 MARIJUANA CROP."

7 Page 3, strike lines 11 through 14 and substitute:

8 "(6) NOTWITHSTANDING ARTICLE 80 OF TITLE 13, TO BRING
9 PROCEEDINGS TO IMPOSE DISCIPLINE, THE SUBJECT OF A COMPLAINT MUST
10 BE GIVEN THE NOTICE REQUIRED IN SECTION 24-4-104 (3) WITHIN ONE
11 YEAR AFTER A COMPLAINT IS RECEIVED OR INITIATED. THIS SUBSECTION
12 (6) DOES NOT APPLY TO COMPLAINTS CONCERNING THE COMMERCIAL
13 APPLICATION OF PESTICIDES ON A MARIJUANA CROP."

14 Page 3, strike lines 19 through 24 and substitute:

15 "(6) NOTWITHSTANDING ARTICLE 80 OF TITLE 13, TO BRING
16 PROCEEDINGS TO IMPOSE CIVIL PENALTIES, THE SUBJECT OF A COMPLAINT
17 MUST BE GIVEN THE NOTICE REQUIRED IN SECTION 24-4-104 (3) WITHIN
18 ONE YEAR AFTER A COMPLAINT IS RECEIVED OR INITIATED. THIS
19 SUBSECTION (6) DOES NOT APPLY TO PROCEEDINGS BASED ON A VIOLATION
20 OF SECTION 35-10-117 (1)(a), (1)(b), OR (1)(c) OR BASED ON COMPLAINTS
21 CONCERNING THE COMMERCIAL APPLICATION OF PESTICIDES ON A
22 MARIJUANA CROP."

23 Page 4, strike lines 2 through 5 and substitute "SECTION MUST BE
24 COMMENCED WITHIN ONE YEAR AFTER A COMPLAINT IS RECEIVED OR
25 INITIATED. THIS SUBSECTION (4) DOES NOT APPLY TO A PROSECUTION
26 BASED ON A VIOLATION OF SECTION 35-10-117 (1)(a), (1)(b), OR (1)(c) OR
27 BASED ON COMPLAINTS CONCERNING THE COMMERCIAL APPLICATION OF
28 PESTICIDES ON A MARIJUANA CROP."
