

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB22-1295 be amended as follows:

1 Amend reengrossed bill, page 340, after line 17 insert:

2 **"26.5-5-328. Applications for licenses - authority to suspend**  
3 **licenses - rules - definitions.** (1) EVERY APPLICATION BY AN INDIVIDUAL  
4 FOR A LICENSE ISSUED BY THE DEPARTMENT OR ANY AUTHORIZED AGENT  
5 OF THE DEPARTMENT MUST REQUIRE THE APPLICANT'S NAME, ADDRESS,  
6 AND SOCIAL SECURITY NUMBER OR TAX IDENTIFICATION NUMBER.

7 (2) THE DEPARTMENT OR ANY AUTHORIZED AGENT OF THE  
8 DEPARTMENT SHALL DENY, SUSPEND, OR REVOKE A LICENSE PURSUANT TO  
9 THE PROVISIONS OF SECTION 26-13-126, AND ANY RULES PROMULGATED  
10 TO IMPLEMENT SAID SECTION, IF THE DEPARTMENT OR AGENT RECEIVES A  
11 NOTICE TO DENY, SUSPEND, OR REVOKE FROM THE STATE CHILD SUPPORT  
12 ENFORCEMENT AGENCY BECAUSE THE LICENSEE OR APPLICANT IS OUT OF  
13 COMPLIANCE WITH A COURT OR ADMINISTRATIVE ORDER FOR CURRENT  
14 CHILD SUPPORT, CHILD SUPPORT DEBT, RETROACTIVE CHILD SUPPORT,  
15 CHILD SUPPORT ARREARAGES, OR CHILD SUPPORT WHEN COMBINED WITH  
16 MAINTENANCE OR BECAUSE THE LICENSEE OR APPLICANT HAS FAILED TO  
17 COMPLY WITH A PROPERLY ISSUED SUBPOENA OR WARRANT RELATING TO  
18 A PATERNITY OR CHILD SUPPORT PROCEEDING. ANY SUCH DENIAL,  
19 SUSPENSION, OR REVOCATION MUST BE IN ACCORDANCE WITH THE  
20 PROCEDURES SPECIFIED BY RULE OF THE DEPARTMENT OF HUMAN  
21 SERVICES AND RULES PROMULGATED BY THE STATE BOARD OF HUMAN  
22 SERVICES FOR THE IMPLEMENTATION SECTION 26-13-126.

23 (3) (a) THE DEPARTMENT SHALL ENTER INTO A MEMORANDUM OF  
24 UNDERSTANDING WITH THE STATE CHILD SUPPORT ENFORCEMENT AGENCY,  
25 WHICH MEMORANDUM MUST IDENTIFY THE RELATIVE RESPONSIBILITIES OF  
26 THE DEPARTMENT AND THE STATE CHILD SUPPORT ENFORCEMENT AGENCY  
27 WITH RESPECT TO THE IMPLEMENTATION OF THIS SECTION AND SECTION  
28 26-13-126.

29 (b) THE EXECUTIVE DIRECTOR MAY PROMULGATE RULES TO  
30 IMPLEMENT THE PROVISIONS OF THIS SECTION.

31 (4) AS USED IN THIS SECTION, "LICENSE" MEANS ANY  
32 RECOGNITION, AUTHORITY, OR PERMISSION THAT THE DEPARTMENT OR  
33 ANY AUTHORIZED AGENT OF THE DEPARTMENT IS AUTHORIZED BY LAW TO  
34 ISSUE FOR AN INDIVIDUAL TO PRACTICE A PROFESSION OR OCCUPATION OR  
35 RECREATIONAL ACTIVITY. "LICENSE" INCLUDES, BUT IS NOT LIMITED TO,  
36 A LICENSE, CERTIFICATE, CERTIFICATION, LETTER OF AUTHORIZATION, OR  
37 REGISTRATION ISSUED FOR AN INDIVIDUAL TO PRACTICE A PROFESSION OR  
38 OCCUPATION OR FOR AN INDIVIDUAL TO PARTICIPATE IN A RECREATIONAL  
39 ACTIVITY."
