SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.

SB22-012 be amended as follows:

1 Amend printed bill, page 3, strike lines 19 through 27.

2 Strike page 4.

3 Page 5, strike lines 1 through 3.

4 Renumber succeeding sections accordingly.

5 Page 5, line 7, strike "DECEMBER 31, 2022," and substitute "FEBRUARY  
6 28, 2023,".

7 Page 5, line 9, strike "FOR CREATING" and substitute "FOR THE CREATION  
8 OF:".

9 Page 5, line 10, strike "A" and substitute:  
10 "(a) A".

11 Page 5, line 23, after "CONSTITUTION." add "THE STATE ARCHIVES SHALL  
12 CONTRACT WITH AN EXHIBIT DESIGN COMPANY TO DETERMINE THE BEST  
13 PRACTICES WHEN PRESENTING THE COLORADO CONSTITUTION IN THE  
14 EXISTING ENVIRONMENTAL CONDITIONS OF THE STATE CAPITOL AND  
15 GOVERNMENT BUILDINGS OTHER THAN THE STATE CAPITOL BUILDING.

16 (b) AN ONLINE EXHIBITION OF THE COLORADO CONSTITUTION,  
17 INCLUDING ALL AMENDMENTS THERETO CURRENTLY IN EFFECT. THE  
18 PROPOSAL SHALL INCLUDE ASPECTS OF EDUCATIONAL OPPORTUNITIES AND  
19 HISTORY AND SHALL ENSURE THAT THE ELECTRONIC COPY OF EACH  
20 VERSION OF THE COLORADO CONSTITUTION CREATED PURSUANT TO THIS  
21 SECTION IS AVAILABLE TO THE PUBLIC IN A SEARCHABLE FORMAT  
22 THROUGH THE WEBSITE OF THE OFFICE OF THE STATE ARCHIVES AND THE  
23 OFFICE OF THE SECRETARY OF STATE. THE STATE ARCHIVES SHALL  
24 CONTRACT WITH AN ONLINE EXHIBIT DESIGN COMPANY TO DETERMINE THE  
25 BEST PRACTICES WHEN PRESENTING THE COLORADO CONSTITUTION IN AN  
26 EDUCATIONAL FORMAT THAT IS EASILY ACCESSIBLE AND USER-FRIENDLY  
27 FOR THE GENERAL POPULATION OF THE STATE. THE EXHIBIT DESIGN  
28 COMPANY MAY COORDINATE AS NECESSARY WITH THE STATE ARCHIVIST,  
29 THE OFFICE OF LEGISLATIVE LEGAL SERVICES, THE SECRETARY OF STATE'S  
30 OFFICE, AND OTHER RELEVANT GOVERNMENT AGENCIES IN THE CREATION  
31 OF THE ONLINE EXHIBITION.

32 (c) OPPORTUNITIES TO PROVIDE UPDATED PHYSICAL COPIES OF THE  
33 CONSTITUTION OR OTHER EDUCATIONAL OPPORTUNITIES RELATED TO THE  
34 UPDATED PHYSICAL COPY OF THE COLORADO CONSTITUTION WITHIN STATE

1 OFFICES. THE PROPOSAL SHALL ENSURE THAT THE CONSTITUTION WILL BE  
2 EASILY ACCESSIBLE AND USER-FRIENDLY FOR THE GENERAL POPULATION  
3 OF THE STATE."
