HB22-1289 be amended as follows:

- 1 Amend printed bill, page 5, line 8, after "INDIVIDUAL" insert "WHO DOES  
2 NOT HAVE EXISTING CREDITABLE COVERAGE".
  
- 3 Page 6, line 24, strike "25.5-5-103," and substitute "25.5-5-103 AND WHO  
4 IS A QUALIFIED INDIVIDUAL WHO MEETS THE ELIGIBILITY CRITERIA  
5 ESTABLISHED IN RULE PURSUANT TO SUBSECTION (4)(c)(IV) OF THIS  
6 SECTION,".
  
- 7 Page 9, line 17, strike "FOR" and substitute "FOR, OR DECLINES TO ENROLL  
8 IN,".
  
- 9 Page 11, line 13, strike "BENEFITS" and substitute "IMPROVEMENTS".
  
- 10 Page 13, line 4, strike "BENEFITS" and substitute "IMPROVEMENTS".
  
- 11 Page 14, strike lines 10 through 13 and substitute "IN COORDINATION  
12 WITH THE DIVISION OF INSURANCE TO ENHANCE OR EXPAND  
13 STATE-SUBSIDIZED INDIVIDUAL HEALTH CARE COVERAGE AS DEFINED IN  
14 SECTION 10-16-1203 (15) AND ONLY IF NEEDED TO MAXIMIZE FEDERAL  
15 FINANCIAL PARTICIPATION FOR COLORADANS RECEIVING STATE MEDICAL  
16 ASSISTANCE PURSUANT TO SECTION 25.5-2-104 OR 25.5-5-201 (6).".
  
- 17 Page 16, line 8, strike "PERIOD." and substitute "PERIOD, SO LONG AS  
18 ELIGIBILITY REMAINS IN EFFECT PURSUANT TO SUBSECTION (4.5)(a) OF  
19 THIS SECTION.".
  
- 20 Page 16, line 24, strike "BENEFITS" and substitute "IMPROVEMENTS".
  
- 21 Page 20, strike lines 18 through 24.
  
- 22 Page 21, lines 18 and 19, strike "BUT SUBJECT TO THE RECEIPT OF  
23 FEDERAL FINANCIAL PARTICIPATION,".
  
- 24 Page 21, line 25, strike "PERIOD." and substitute "PERIOD, SO LONG AS  
25 ELIGIBILITY REMAINS IN EFFECT PURSUANT TO SUBSECTION (5.5)(a) OF  
26 THIS SECTION.".
  
- 27 Page 22, line 11, strike "BENEFITS" and substitute "IMPROVEMENTS".
