HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB18-1343 be amended as follows:

- 1 Amend printed bill, page 3, line 3, after "(5.5)" insert "and (8.5)".
- 2 Page 3, strike lines 21 through 27.
- 3 Page 4, strike lines 1 through 3 and substitute:
  - 4 "(5) "Integrated service and support center" means a nonprofit
  - 5 center that is affiliated with a work force center and veterans service
  - 6 offices ~~or provides financial classes or houses a small business~~
  - 7 ~~development center~~ IN A CENTRALIZED LOCATION WHERE GOVERNMENT
  - 8 AGENCIES, NONPROFIT ORGANIZATIONS, AND OTHER ENTITIES
  - 9 COLLABORATE TO PROVIDE SERVICES TO ELIGIBLE PARTICIPANTS.
  - 10 SERVICES OFFERED MAY INCLUDE ASSISTANCE FOR ELIGIBLE PARTICIPANTS
  - 11 IN SECURING FEDERAL BENEFITS, COUNSELING SERVICES, EMPLOYMENT
  - 12 SUPPORT, EDUCATION, LIFE SKILLS, AND WELLNESS SUPPORT."
- 13 Page 4, after line 10 insert:
  - 14 (8.5) "WORK-BASED LEARNING" MEANS A CONTINUUM OF
  - 15 ACTIVITIES THAT OCCUR, IN PART OR IN WHOLE, IN THE WORKPLACE,
  - 16 PROVIDING THE LEARNER WITH HANDS-ON, REAL-WORLD WORK
  - 17 EXPERIENCE."
- 18 Page 4, line 18, after "VETERANS;" add "AND".
- 19 Page 4, strike lines 20 through 24 and substitute "APPLICATION".
- 20 Page 4, line 26, strike "(1)(d), (1)(e)".
- 21 Page 4, line 27, strike "(1)(f)" and substitute "(1.5)".
- 22 Page 5, strike lines 13 through 17 and substitute:
  - 23 "(1.5) THE DEPARTMENT SHALL COLLABORATE WITH
  - 24 STAKEHOLDERS AND, IF FEASIBLE, DEVELOP A GRANT APPLICATION FORM
  - 25 BY MARCH 1, 2019, SO THAT A NONPROFIT AGENCY MAY SUBMIT ONE
  - 26 APPLICATION FOR MULTIPLE SERVICE CENTERS EFFECTIVE WITH THE FISCAL
  - 27 YEAR 2019-20 GRANT CYCLE."
- 28 Page 5, line 24, strike "funding, through the act," and substitute "funding
- 29 through the act,".

1 Page 5, strike lines 25 and 26 and substitute "available or is limited OR IF  
2 THE USE OF FUNDS IS NOT ALLOWABLE under the act, the ~~veteran, spouse,~~  
3 or eligible participant may use program".

4 Page 6, line 23, strike "BARRIERS TO ACCESS," and substitute  
5 "SIGNIFICANT BARRIERS TO EMPLOYMENT, INCLUDING THOSE SPECIFIED IN  
6 38 U.S.C. SEC. 4100 ET SEQ.,".

7 Page 8, line 13, strike "NOVEMBER 1, 2018." and substitute "JANUARY 1,  
8 2019. THE GRANT PERIOD MAY BE EXTENDED FOR ONE YEAR SUBJECT TO  
9 MONEY APPROPRIATED BY THE GENERAL ASSEMBLY.".

10 Page 9, strike lines 21 and 22 and substitute:

11 "8-14.3-205. **Repeal of part.** This part 2 is repealed, effective  
12 ~~January 1, 2019~~ JANUARY 1, 2024.".
