Committee on Judiciary.

HB20-1019 be amended as follows:

- 1 Amend printed bill, page 8, line 14, strike "(1),".
- 2 Page 8, line 15, strike "(2), and".
- 3 Page 8, strike lines 16 through 24 and substitute:
- 4 "18-8-208. Escapes. (11) IF a person who is SERVING A DIRECT
- 5 SENTENCE TO A".
- 6 Page 9, line 1, strike "PAROLE".
- 7 Page 9, line 2, after "IS" insert "PARTICIPATING IN A WORK RELEASE OR
- 8 HOME DETENTION PROGRAM PURSUANT TO SECTION 18-1.3-106 (1.1),
- 9 INTENSIVE SUPERVISION PROGRAM OR ANY OTHER SIMILAR AUTHORIZED
- 10 SUPERVISED OR UNSUPERVISED ABSENCE FROM A DETENTION FACILITY AS
- 11 DEFINED IN SECTION 18-8-203 (3), IS HOUSED IN A STAFF SECURE FACILITY
- 12 AS DEFINED IN SECTION 19-1-103 (101.5), OR IS".
- 13 Page 9, strike line 7 and substitute "(1.5); and **repeal** (6) as follows".
- 14 Page 9, strike lines 8 through 14 and substitute:
- 15 "18-8-208.1. Attempt to escape. (1.5) ~~If a person, while in~~
- 16 ~~custody or confinement following~~".
- 17 Page 9, line 25, strike "PAROLE".
- 18 Page 9, line 26, after "IS" insert "PARTICIPATING IN A WORK RELEASE OR
- 19 HOME DETENTION PROGRAM PURSUANT TO SECTION 18-1.3-106 (1.1),
- 20 INTENSIVE SUPERVISION PROGRAM OR ANY OTHER SIMILAR AUTHORIZED
- 21 SUPERVISED OR UNSUPERVISED ABSENCE FROM A DETENTION FACILITY AS
- 22 DEFINED IN SECTION 18-8-203 (3), IS HOUSED IN A STAFF SECURE FACILITY
- 23 AS DEFINED IN SECTION 19-1-103 (101.5), OR IS".
- 24 Page 10, strike lines 4 through 10 and substitute:
- 25 "~~(6) A person who participates in a work release program, a home~~
- 26 ~~detention program, as defined in section 18-1.3-106 (1.1), a furlough, an~~
- 27 ~~intensive supervision program, or any other similar authorized supervised~~
- 28 ~~or unsupervised absence from a detention facility, as defined in section~~
- 29 ~~18-8-203 (3), and who is required to report back to the detention facility~~
- 30 ~~at a specified time shall be deemed to be in custody.~~".
