**A BILL FOR AN ACT**

101 **CONCERNING THE THREE YEAR PERIOD THAT CAPITAL CONSTRUCTION**  
102 **APPROPRIATIONS REMAIN AVAILABLE.**

---

**Bill Summary**

**Capital Development Committee.** The bill clarifies the 3-year period that capital construction appropriations remain available.

1 *Be it enacted by the General Assembly of the State of Colorado:*

1           **SECTION 1.** In Colorado Revised Statutes, 24-75-303, add (5)  
2 as follows:

3           **24-75-303. Appropriation for capital construction.** (5) EXCEPT  
4 FOR AN APPROPRIATION FOR A LEASE-PURCHASE PAYMENT AND UNLESS  
5 OTHERWISE NOTED IN A FOOTNOTE IN AN APPROPRIATION ACT, AN  
6 APPROPRIATION FOR A CAPITAL CONSTRUCTION BUDGET ITEM OR AN  
7 INFORMATION TECHNOLOGY CAPITAL PROJECT, INCLUDING CAPITAL  
8 CONSTRUCTION, CONTROLLED MAINTENANCE, OR CAPITAL RENEWAL  
9 PROJECTS, AS SUCH TERMS ARE DEFINED IN SECTION 24-30-1301,  
10 INCLUDED IN:

11           (a) THE ANNUAL GENERAL APPROPRIATION ACT IS AVAILABLE FOR  
12 EXPENDITURE UPON ENACTMENT OF THE ACT AND REMAINS AVAILABLE  
13 FOR EXPENDITURE FOR THREE FULL FISCAL YEARS COMMENCING WITH THE  
14 FISCAL YEAR FOR WHICH THE ANNUAL GENERAL APPROPRIATION ACT IS  
15 ENACTED, OR UNTIL THE PROJECT IS COMPLETED, WHICHEVER IS FIRST;  
16 AND

17           (b) A SUPPLEMENTAL APPROPRIATION ACT AUTHORIZED PURSUANT  
18 TO SECTIONS 24-37-304, 2-3-208, 24-75-111 (5), OR 24-75-111.5 (5) IS  
19 AVAILABLE FOR EXPENDITURE UPON ENACTMENT OF THE SUPPLEMENTAL  
20 APPROPRIATION ACT AND REMAINS AVAILABLE FOR EXPENDITURE FOR  
21 THREE FULL FISCAL YEARS COMMENCING WITH THE FISCAL YEAR DURING  
22 WHICH THE SUPPLEMENTAL APPROPRIATION ACT WAS ENACTED, OR UNTIL  
23 THE PROJECT IS COMPLETED, WHICHEVER IS FIRST.

24           **SECTION 2. Applicability.** This act applies to appropriations for  
25 capital construction enacted on or after the effective date of this act.

26           **SECTION 3. Safety clause.** The general assembly hereby finds,

1 determines, and declares that this act is necessary for the immediate  
2 preservation of the public peace, health, and safety.
