Of the five appointed by the governor:

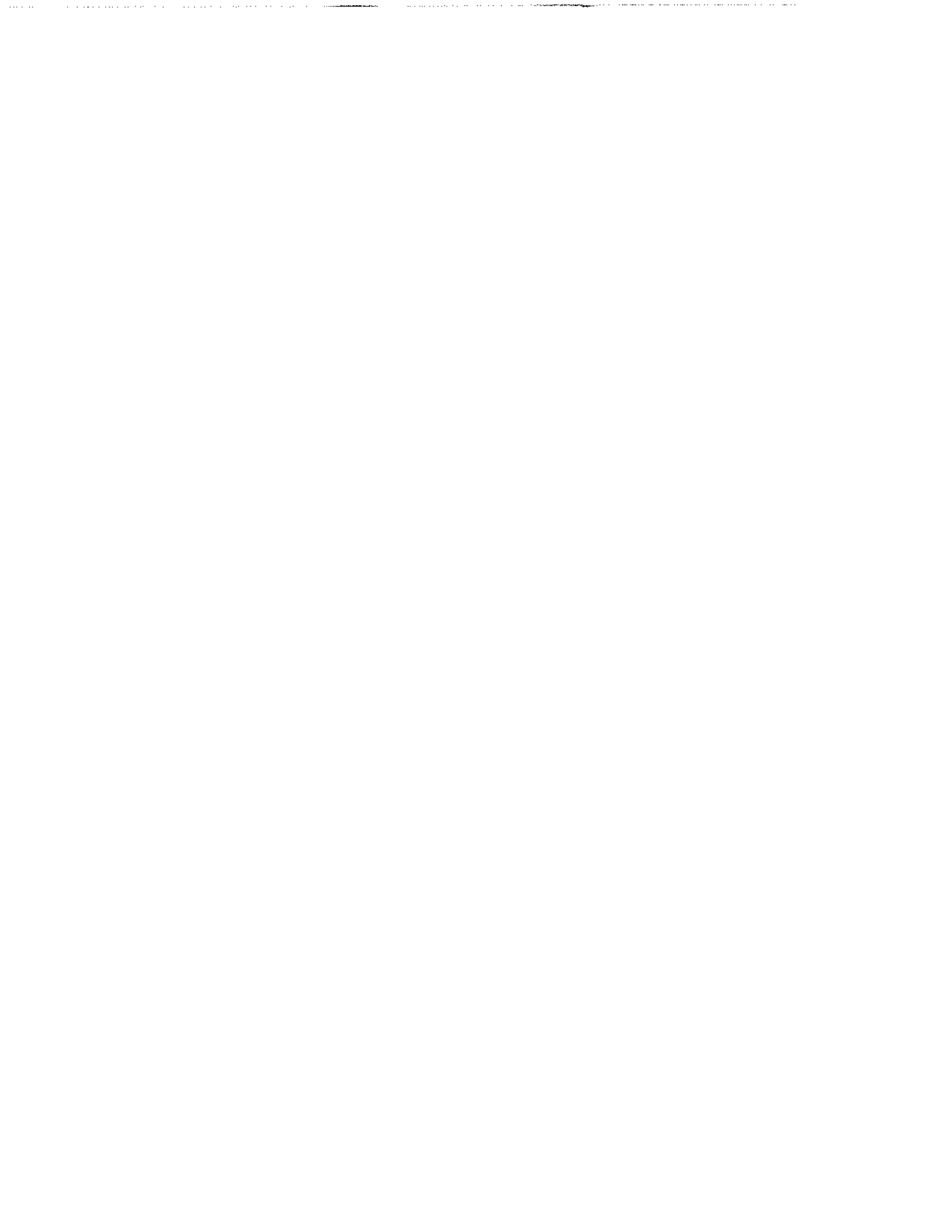
- two members must have substantial experience in the mining industry; and
