HOUSE COMMITTEE OF REFERENCE AMENDMENT
Committee on Agriculture, Livestock, & Natural Resources.
HB17-1282 be amended as follows:

1 Amend printed bill, page 2, strike lines 2 through 6 and substitute:

2 "SECTION 1. In Colorado Revised Statutes, add part 10 to
3 article 31 of title 23 as follows:

4 PART 10
5 VETERINARY EDUCATION LOAN
6 REPAYMENT PROGRAM

7 23-31-1001. Legislative declaration. (1) THE GENERAL
8 ASSEMBLY".

9 Page 3, strike line 20 and substitute:

10 "23-31-1002. Definitions - rules. AS USED IN THIS PART 10,".

11 Page 3, line 23, strike "35-82-103." and substitute "23-31-1003.".

12 Page 3, line 27, strike "35-82-104." and substitute "23-31-1004.".

13 Page 4, strike lines 1 through 9 and substitute:

14 "(4) "RURAL" MEANS:

15 (a) A COUNTY WITH A POPULATION OF FEWER THAN FIFTY
16 THOUSAND; OR

17 (b) A MUNICIPALITY WITH A POPULATION OF FEWER THAN TWENTY
18 THOUSAND IF THE MUNICIPALITY IS NOT CONTIGUOUS TO A MUNICIPALITY
19 WITH A POPULATION OF TWENTY THOUSAND OR MORE.".

20 Page 4, strike lines 15 through 23 and substitute:

21 "23-31-1003. State veterinary education loan repayment
22 council - creation - membership. (1) THERE IS HEREBY CREATED IN
23 COLORADO STATE UNIVERSITY'S COLLEGE OF VETERINARY MEDICINE AND
24 BIOMEDICAL SCIENCES THE VETERINARY EDUCATION LOAN REPAYMENT
25 COUNCIL, REFERRED TO IN THIS PART 10 AS THE "COUNCIL". THE COUNCIL
26 SHALL BE UNDER THE DIRECT SUPERVISION OF THE DEAN OF COLORADO
27 STATE UNIVERSITY'S COLLEGE OF VETERINARY MEDICINE AND BIOMEDICAL
28 SCIENCES OR THE DEAN'S DESIGNEE. THE DEAN OR THE DEAN'S DESIGNEE
29 MAY AUTHORIZE STAFF ASSISTANCE TO PROVIDE ADMINISTRATIVE



1 SUPPORT FOR THE COUNCIL IF SUCH STAFF ASSISTANCE CAN BE PROVIDED
2 WITHIN COLORADO STATE UNIVERSITY'S EXISTING APPROPRIATIONS."

3 Page 5, strike lines 11 and 12 and substitute:

4 "(B) THE COMMISSIONER OF AGRICULTURE OR HIS OR HER
5 DESIGNEE;"

6 Page 6, line 14, strike "ARTICLE 82." and substitute "PART 10."

7 Page 6, line 17, strike "35-82-104." and substitute "23-31-1004."

8 Page 6, line 18, strike "SHALL" and substitute "SHALL, TO THE EXTENT
9 THAT THE COUNCIL RECEIVES SUFFICIENT GIFTS, GRANTS, OR DONATIONS
10 TO COVER THE COSTS OF AWARDING LOAN REPAYMENTS,"

11 Page 6, strike lines 24 through 26 and substitute:

12 "23-31-1005. Council powers and duties. (1) TO IMPLEMENT
13 THIS PART 10, THE COUNCIL SHALL:

14 (a) PURSUANT TO THE CRITERIA SET FORTH IN SECTION
15 23-31-1006,"

16 Page 7, line 6, strike "35-82-107;" and substitute "23-31-1007;"

17 Page 7, line 13, strike "35-82-109," and substitute "23-31-1009,"

18 Page 7, strike line 17 and substitute "23-31-1006 (2); AND"

19 Page 7, line 25, strike "ARTICLE 82," and substitute "PART 10,"

20 Page 8, line 13, strike "35-82-106." and substitute "23-31-1006."

21 Page 8, strike line 25 and substitute "23-31-1007; AND"

22 Page 9, strike line 15 and substitute "23-31-1009; AND"

23 Page 10, line 22, strike "35-82-107." and substitute "23-31-1007."

24 Page 11, line 20, strike "35-82-108." and substitute "23-31-1008."
