- 25 "SECTION 14. In Colorado Revised Statutes, 33-6-114, amend
26 (4) as follows:



1 **33-6-114. Transportation, importation, exportation, and**
2 **release of wildlife.** (4) Any person who violates this section is guilty of
3 a misdemeanor and, upon conviction, thereof, shall be punished by a fine
4 of ONE HUNDRED fifty dollars for violations involving native wildlife and
5 by a fine of not less than two hundred fifty dollars nor more than one
6 thousand dollars for violations involving nonnative or exotic wildlife. In
7 addition, for violations involving either native wildlife or nonnative or
8 exotic wildlife, five license suspension points per incident may be
9 assessed by the division against an individual's license privileges."

15 Page 23, strike line 17 and substitute "THE FEE BY AN AMOUNT UP TO THE
16 TOTAL AMOUNT REFLECTED BY THE CHANGES MADE".

17 Page 23, line 21, strike "INDEX." and substitute "INDEX AFTER THE
18 EFFECTIVE DATE OF THIS SUBSECTION (2)(d)(II)."

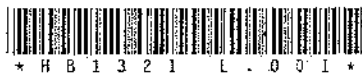
19 Page 25, strike line 5 and substitute "TOTAL AMOUNT REFLECTED BY THE
20 CHANGES MADE IN THE UNITED STATES BUREAU OF".

21 Page 25, line 9, strike "INDEX." and substitute "INDEX AFTER THE
22 EFFECTIVE DATE OF THIS SUBSECTION (5)(a), AS AMENDED."

23 Page 27, after line 22 insert:

24 **"SECTION 23.** In Colorado Revised Statutes, amend 33-12-105
25 as follows:

26 **33-12-105. Licensing violations.** (1) Except as otherwise
27 provided in section 33-12-104, it is unlawful for any person to transfer,
28 sell, or assign any pass, PERMIT, STICKER, LICENSE, or registration issued
29 under articles 10 to 15 AND 32 of this title TITLE 33 to another person.
30 Any person who violates this subsection (1) is guilty of a class 2 petty
31 offense MISDEMEANOR and, upon conviction, shall be punished by a fine



1 of two hundred dollars.

2 (2) Any person who makes any false statement or gives any false
3 information in connection with purchasing or selling a pass, PERMIT,
4 STICKER, LICENSE, or registration or who makes any alteration of a pass,
5 PERMIT, STICKER, LICENSE, or registration is guilty of a ~~class 2 petty~~
6 ~~offense~~ MISDEMEANOR and, upon conviction, shall be punished by a fine
7 of two hundred dollars, and any such statement, information, or alteration
8 shall ~~render such~~ RENDERS THE pass, PERMIT, STICKER, LICENSE, or
9 registration void.

10 (3) Any person who fails to obtain or make readily available for
11 inspection by a parks and recreation officer or other peace officer an
12 appropriate and valid pass, PERMIT, STICKER, LICENSE, OR REGISTRATION
13 is guilty of a ~~class 2 petty offense~~ MISDEMEANOR and, upon conviction,
14 shall be punished by a fine of ~~twenty-five~~ TWO HUNDRED dollars."
