HOUSE COMMITTEE OF REFERENCE AMENDMENT
 Committee on Agriculture, Livestock, & Natural Resources.
HB17-1321 be amended as follows:

1 Amend printed bill, page 8, line 15, strike "(14)(c)" and substitute (14)(c); -
 2 and add (2.5)".

3 Page 14, after line 22 insert:

4 "(2.5) (a) THE COMMISSION, BEFORE JANUARY 1, 2020, MAY ONLY
 5 INCREASE A RESIDENT LICENSE FEE BY HALF OF THE DIFFERENCE BETWEEN
 6 THE MAXIMUM FEE AMOUNT AUTHORIZED BY HOUSE BILL 17-1321,
 7 ENACTED IN 2017, AND THE AMOUNT OF THE FEE ON THE EFFECTIVE DATE
 8 OF THIS SUBSECTION (2.5). ON AND AFTER JANUARY 1, 2020, THE
 9 COMMISSION MAY INCREASE A RESIDENT LICENSE FEE UP TO THE MAXIMUM
 10 FEE AMOUNT AUTHORIZED IN THIS SECTION BY HOUSE BILL 17-1321,
 11 ENACTED IN 2017.

12 (b) THE LIMITATION ON LICENSE FEE INCREASES SET FORTH IN
 13 SUBSECTION (2.5)(a) OF THIS SECTION DOES NOT APPLY TO THE FOLLOWING
 14 LICENSE FEE OR SURCHARGE INCREASES:

15 (I) THE MIGRATORY WATERFOWL STAMP AUTHORIZED IN
 16 SUBSECTION (1.4)(bb) OF THIS SECTION;

17 (II) NONRESIDENT LICENSE FEE INCREASES;

18 (III) LICENSES ISSUED FOR WHICH A FEE IS NOT PROVIDED, AS
 19 AUTHORIZED IN SUBSECTION (3) OF THIS SECTION;

20 (IV) THE FEE FOR REPLACEMENT LICENSES AUTHORIZED IN
 21 SUBSECTION (8) OF THIS SECTION;

22 (V) THE WILDLIFE COUNCIL SURCHARGE AUTHORIZED IN
 23 SUBSECTION (8.5)(a) OF THIS SECTION; AND

24 (VI) THE NONREFUNDABLE PROCESSING FEE FOR LICENSE DRAWING
 25 APPLICATIONS AUTHORIZED IN SUBSECTION (11) OF THIS SECTION."

26 Page 22, line 15, strike "AMENDED." and substitute: "AMENDED; EXCEPT
 27 THAT, BEFORE JANUARY 1, 2020, A PARK FEE OR CHARGE SHALL NOT BE
 28 RAISED BY MORE THAN HALF OF THE DIFFERENCE BETWEEN THE MAXIMUM
 29 FEE OR CHARGE AMOUNT AUTHORIZED BY HOUSE BILL 17-1321, ENACTED
 30 IN 2017, AND THE AMOUNT OF THE FEE OR CHARGE ON THE EFFECTIVE
 31 DATE OF THIS SUBSECTION (4)(b)(I), AS AMENDED. ON OR AFTER JANUARY
 32 1, 2020, THE COMMISSION MAY INCREASE A PARK FEE OR CHARGE UP TO
 33 THE MAXIMUM FEE OR CHARGE AMOUNT AUTHORIZED IN THIS SUBSECTION
 34 (4)(b)(I) BY HOUSE BILL 17-1321, ENACTED IN 2017."
