## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs and Labor.

SB17-240 be amended as follows:

- 1 Amend reengrossed bill, page 10 strike lines 13 through 19 and substitute:
  - 2 "(14) (20) "Motor vehicle salesperson" means a natural person
  - 3 who, for a salary, commission, or compensation of any kind, is employed
  - 4 either directly or indirectly, regularly or occasionally, by a motor vehicle
  - 5 dealer or used motor vehicle dealer to sell, lease, purchase, or exchange
  - 6 or to negotiate for the sale, lease, purchase, or exchange of motor
  - 7 vehicles."

- 18 Page 27, line 10, after "BOARD" insert "OR THE EXECUTIVE DIRECTOR".
- 19 Page 29, line 6, strike "INITIAL".
- 20 Page 29, strike lines 13 through 16.
- 21 Renumber succeeding subparagraph accordingly.
- 22 Page 30, strike lines 9 through 12.
- 23 Page 33, line 15, strike "to the board" and substitute "to the board".
- 24 Page 38, line 4, strike "DIRECTOR;" and substitute "DIRECTOR OR THE
- 25 BOARD;".

- 7 DIVISION".
  
- 8 Page 43, line 19, after "BOARD" insert "OR THE EXECUTIVE DIRECTOR".

- 10 Page 45, line 17, strike "INITIAL".
