HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB17-1324 be amended as follows:

1 Amend printed bill, page 10, after line 12 insert:

2 "(4) (a) TO ENSURE THAT THE CREDITS ALLOWED BY SUBSECTIONS
3 (2) AND (3) OF THIS SECTION ARE ALLOWED ONLY TO QUALIFIED RURAL
4 TEACHERS AND QUALIFIED RURAL STUDENT TEACHERS WHO ARE ELIGIBLE
5 FOR THE CREDITS, NO LATER THAN DECEMBER 1 OF EACH INCOME TAX
6 YEAR COMMENCING ON OR AFTER JANUARY 1, 2018, THE DEPARTMENT OF
7 EDUCATION SHALL SUBMIT TO THE DEPARTMENT OF REVENUE:

8 (I) A LIST OF ALL QUALIFIED RURAL TEACHERS WHO ARE ELIGIBLE
9 FOR A CREDIT ALLOWED BY SUBSECTION (2)(a), (2)(b), (2)(c), (2)(d), OR
10 (2)(e) OF THIS SECTION FOR THE INCOME TAX YEAR THAT SPECIFICALLY
11 IDENTIFIES THE AMOUNT OF THE CREDIT ALLOWED FOR EACH TEACHER;
12 AND

13 (II) A LIST OF ALL QUALIFIED RURAL STUDENT TEACHERS WHO ARE
14 ELIGIBLE FOR THE CREDIT ALLOWED BY SUBSECTION (3) OF THIS SECTION
15 FOR THE INCOME TAX YEAR.

16 (b) THE DEPARTMENT OF EDUCATION SHALL COORDINATE WITH
17 THE DEPARTMENT OF REVENUE TO ENSURE THAT THE LISTS PROVIDED TO
18 THE DEPARTMENT OR REVENUE PURSUANT TO SUBSECTION (4)(a) OF THIS
19 SECTION PROVIDE SUFFICIENT INFORMATION, INCLUDING, TO THE EXTENT
20 DEEMED NECESSARY BY THE DEPARTMENT OF REVENUE, MAILING
21 ADDRESSES AND COMPLETE OR PARTIAL SOCIAL SECURITY NUMBERS, TO
22 ALLOW THE DEPARTMENT OF REVENUE TO MATCH THE INDIVIDUALS
23 IDENTIFIED ON THE LISTS WITH THEIR INCOME TAX RETURNS.

24 (c) IF NECESSARY TO ALLOW THE DEPARTMENT OF EDUCATION TO
25 OBTAIN THE INFORMATION NEEDED TO PROVIDE LISTS TO THE
26 DEPARTMENT OF REVENUE AS REQUIRED BY SUBSECTION (4)(a) OF THIS
27 SECTION, THE DEPARTMENT OF EDUCATION SHALL MODIFY ITS ELECTRONIC
28 EDUCATOR LICENSING SYSTEM TO ACCEPT OR REQUIRE STUDENT TEACHER
29 LICENSING INFORMATION."
