## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB17-1027 be amended as follows:

1 Amend printed bill, page 2, strike line 3 and substitute "(4)(b)(III)(C),  
2 (4)(b)(V), and (4)(b)(VII) as follows:".

3 Page 2, line 6, strike "**audit.**" and substitute "**annual fund review.**".

4 Page 2, strike line 7 and substitute:

5 "(4) (b) (III) At least quarterly, the state treasurer shall transfer all  
6 available moneys from the Emily Maureen Ellen Keyes organ and tissue  
7 donation awareness fund:

8 (C) Before any payment to Donor Alliance, Inc., or its successor  
9 organization, from the Emily Maureen Ellen Keyes organ and tissue  
10 donation awareness fund may be made for any purpose, to the department  
11 for the reasonable costs associated with the initial installation of the organ  
12 and tissue donor registry, the setup for electronic transfer of the donor  
13 information for the organ and tissue donor registry to the federally  
14 designated organ procurement organization, and computer programming,  
15 REPROGRAMMING, and form changes necessary as a result of the creation  
16 OR MODIFICATION of the organ and tissue donor registry.

17 (V) An applicant may make a donation of one dollar or more to".

18 Page 3, line 14, strike "A DRIVER'S LICENSE OR" and substitute "AN  
19 IDENTIFICATION CARD, A DRIVER'S LICENSE, OR AN".

20 Page 3, strike lines 19 through 22 and substitute:

21 "~~(VII) This paragraph (b) is repealed July 1, 2018 DONOR~~  
22 ~~ALLIANCE, INC., OR ITS SUCCESSOR ORGANIZATION, SHALL SUBMIT TO THE~~  
23 ~~STATE AUDITOR AN ANNUAL REPORT DETAILING THE AMOUNTS AND~~  
24 ~~SPECIFIC USES OF ALL FUNDS RECEIVED BY DONOR ALLIANCE, INC., FROM~~

27 Page 5, line 1, strike "**Periodic audits**" and substitute "**Annual review**".

28 Page 5, line 3, strike "TEN YEARS" and insert "YEAR".

29 Page 5, strike line 4 and substitute "SHALL REVIEW THE ANNUAL REPORT



1 SUBMITTED BY DONOR ALLIANCE, INC., OR ITS SUCCESSOR ORGANIZATION,  
2 REGARDING THE USE OF FUNDS RECEIVED FROM".

3 Page 5, line 6, strike "THE STATE".

4 Page 5, strike lines 7 and 8 and substitute "AFTER REVIEWING EACH  
5 ANNUAL REPORT FROM DONOR ALLIANCE, INC., THE STATE AUDITOR MAY  
6 PREPARE A REPORT AND".

7 Page 5, strike lines 10 through 19 and substitute:

8           **"SECTION 4. Act subject to petition - effective date.** This act  
9 takes effect September 15, 2017; except that, if a referendum petition is  
10 filed pursuant to section 1 (3) of article V of the state constitution against  
11 this act or an item, section, or part of this act within the ninety-day period  
12 after final adjournment of the general assembly, then the act, item,  
13 section, or part will not take effect unless approved by the people at the  
14 general election to be held in November 2018 and, in such case, will take  
15 effect on the date of the official declaration of the vote thereon by the  
16 governor."

17 Page 1, line 104 strike "AUDIT EVERY TEN YEARS," and substitute  
18 "ANNUAL REVIEW OF THE USE OF DONATED FUNDS,".
