HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB17-1176 be amended as follows:

1 Amend printed bill, page 4, line 17, strike "A" and substitute "SUBJECT
2 TO THE PROVISIONS OF SUBSECTION (1.9)(e) OF THIS SECTION, A".

3 Page 6, after line 12 insert:

4 "(e) A TEACHER WHO RETIRES BEFORE HE OR SHE HAS MET THE
5 AGE AND SERVICE CREDIT REQUIREMENTS FOR FULL SERVICE RETIREMENT
6 BENEFITS PURSUANT TO SECTION 24-51-602 SHALL NOT BE EMPLOYED
7 AFTER RETIREMENT PURSUANT TO THIS SUBSECTION (1.9) BY THE
8 EMPLOYER IN THE SCHOOL DIVISION THAT WAS THE TEACHER'S LAST
9 EMPLOYER UNTIL TWO YEARS AFTER THE TEACHER'S DATE OF RETIREMENT.

10 (f) ON OR BEFORE DECEMBER 1, 2020, THE ASSOCIATION SHALL
11 SUBMIT A REPORT TO THE FINANCE COMMITTEES OF THE HOUSE OF
12 REPRESENTATIVES AND THE SENATE, OR ANY SUCCESSOR COMMITTEES,
13 REGARDING THE EMPLOYMENT AFTER SERVICE RETIREMENT PROVISIONS
14 OF THIS SUBSECTION (1.9). THE EMPLOYERS IN THE SCHOOL DIVISION OF
15 THE ASSOCIATION THAT EMPLOY TEACHERS, SCHOOL BUS DRIVERS, OR
16 SCHOOL FOOD SERVICES COOKS PURSUANT TO THIS SUBSECTION (1.9)
17 SHALL PROVIDE INFORMATION REQUESTED BY THE ASSOCIATION FOR THE
18 PURPOSES OF THE REPORT. THE REPORT SHALL INCLUDE:

19 (I) THE NUMBER OF TEACHERS, SCHOOL BUS DRIVERS, AND SCHOOL
20 FOOD SERVICES COOKS WHO HAVE BEEN EMPLOYED AFTER SERVICE
21 RETIREMENT PURSUANT TO THIS SUBSECTION (1.9) AS OF THE DATE OF THE
22 REPORT;

23 (II) THE EXTENT TO WHICH THIS SUBSECTION (1.9) HAS HELPED
24 EMPLOYERS IN THE SCHOOL DIVISION ADDRESS TEACHER, SCHOOL BUS
25 DRIVER, AND SCHOOL FOOD SERVICES COOK SHORTAGES;

26 (III) THE COSTS, IF ANY, TO THE ASSOCIATION AS A RESULT OF THIS
27 SUBSECTION (1.9); AND

28 (IV) ANY OTHER INFORMATION DEEMED RELEVANT BY THE
29 ASSOCIATION."

30 Reletter succeeding paragraph accordingly.
