HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health, Insurance, & Environment.

HB16-1324 be amended as follows:

1 Amend printed bill, page 2, line 20, strike "DISPENSED." and substitute
 2 "DISPENSED, BUT ONLY IF THE NONRESIDENT PHARMACY OUTLET HAS
 3 PROVIDED THE BOARD WITH A COPY OF THE MOST RECENT INSPECTION OF
 4 THE NONRESIDENT PHARMACY OUTLET BY THE AGENCY THAT REGULATES
 5 PHARMACEUTICALS IN THE STATE OF RESIDENCE AND INFORMATION ABOUT
 6 THE PROCEDURE AND CRITERIA OF INSPECTIONS IN THAT STATE, AND THE
 7 BOARD APPROVES THE INSPECTION REPORT AND THE STATE'S INSPECTION
 8 PROCEDURE AND CRITERIA AS SATISFACTORILY DEMONSTRATING PROOF OF
 9 COMPLIANCE WITH THE BOARD'S OWN INSPECTION PROCEDURE AND
 10 CRITERIA. THE BOARD MAY PROMULGATE RULES CONCERNING ITS REVIEW
 11 OF NONRESIDENT PHARMACY OUTLET INSPECTIONS."

12 Page 4, line 9, after "(d)" insert "(I)".

13 Page 4, line 10, strike "(I)" and substitute "(A)".

14 Page 4, line 13, strike "(II)" and substitute "(B)".

15 Page 4, after line 14 insert:

16 "(II) NOTWITHSTANDING SUBPARAGRAPH (I) OF THIS PARAGRAPH
 17 (d), "PRESCRIPTION DRUG OUTLET" DOES NOT INCLUDE A NONRESIDENT
 18 PHARMACY OUTLET UNLESS THE NONRESIDENT PHARMACY OUTLET HAS
 19 PROVIDED THE BOARD WITH A COPY OF THE MOST RECENT INSPECTION OF
 20 THE NONRESIDENT PHARMACY BY THE AGENCY THAT REGULATES
 21 PHARMACEUTICALS IN THE STATE OF RESIDENCE AND INFORMATION ABOUT
 22 THE PROCEDURE AND CRITERIA FOR INSPECTIONS IN THAT STATE, AND THE
 23 BOARD HAS APPROVED THE INSPECTION REPORT AND THE STATE'S
 24 INSPECTION PROCEDURE AND CRITERIA AS SATISFACTORILY
 25 DEMONSTRATING PROOF OF COMPLIANCE WITH THE BOARD'S OWN
 26 INSPECTION PROCEDURE AND CRITERIA."

27 Page 5, after line 10 insert:

28 "SECTION 5. **Effective date.** This act takes effect January 1,
 29 2017."
