HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health, Insurance, & Environment.

HB16-1435 be amended as follows:

1 Amend printed bill, page 5, after line 4 insert:

2 "(2) "COVERED EMPLOYER" MEANS:

3 (a) THE STATE, EACH COUNTY, CITY AND COUNTY, CITY, TOWN,  
4 AND IRRIGATION AND SCHOOL DISTRICT OF THE STATE, AND ANY PUBLIC  
5 INSTITUTIONS OR ADMINISTRATIVE BOARD THEREOF THAT HAS TWO  
6 HUNDRED FIFTY OR MORE EMPLOYEES EMPLOYED IN COLORADO, SOME OR  
7 ALL OF WHOM ARE LOW-WAGE EMPLOYEES; AND

8 (b) EVERY PERSON, ASSOCIATION OF PERSONS, FIRM, OR PRIVATE  
9 CORPORATION, INCLUDING ANY PUBLIC SERVICE CORPORATION, MANAGER,  
10 PERSONAL REPRESENTATIVE, ASSIGNEE, TRUSTEE, AND RECEIVER, WHO  
11 HAS TWO HUNDRED FIFTY OR MORE INDIVIDUALS REGULARLY ENGAGED IN  
12 THE SAME BUSINESS OR EMPLOYMENT IN COLORADO, SOME OR ALL OF  
13 WHOM ARE LOW-WAGE EMPLOYEES, IN SERVICE UNDER ANY EXPRESSED OR  
14 IMPLIED CONTRACT OF HIRE."

16 Page 5, strike lines 18 through 27.

17 Page 6, strike line 1.

18 Renumber succeeding subsections accordingly.

19 Page 6, after line 8 insert:

20 "(8) "LOW WAGE" MEANS A REGULAR RATE OF PAY THAT IS:

21 (a) LESS THAN TWELVE DOLLARS PER HOUR FOR THE CALENDAR  
22 YEAR 2018; AND

23 (b) LESS THAN TWELVE DOLLARS PER HOUR ANNUALLY ADJUSTED  
24 FOR INFLATION AS MEASURED BY THE CONSUMER PRICE INDEX FOR ALL  
25 URBAN CONSUMERS FOR THE DENVER-BOULDER-GREELEY, COLORADO  
26 METROPOLITAN AREA FOR CALENDAR YEAR 2019 AND FOR EACH  
27 CALENDAR YEAR THEREAFTER."

29 Page 6, line 10, strike "OF LESS THAN TWELVE DOLLARS PER HOUR."



1 Page 6, strike lines 11 through 13 and substitute "THAT IS A LOW WAGE;  
2 EXCEPT THAT "LOW-WAGE EMPLOYEE" DOES NOT INCLUDE AN EMPLOYEE,  
3 INCLUDING AN EMPLOYEE PARTICIPATING IN AN INTERNSHIP, WHO IS BEING  
4 PAID FOR HIS OR HER PARTICIPATION IN A WORKFORCE DEVELOPMENT  
5 TRAINING PROGRAM IF:

6 (a) THE PROGRAM IS SPONSORED BY, COORDINATED WITH, OR  
7 OTHERWISE FORMALLY RECOGNIZED BY THE FEDERAL GOVERNMENT OR  
8 THE GOVERNMENT OF THIS STATE;

9 (b) THE PARTICIPATION OF THE EMPLOYEE IN THE TRAINING  
10 PROGRAM IS INTENDED TO BE TEMPORARY IN NATURE; AND

11 (c) UPON SUCCESSFUL COMPLETION OF THE TRAINING PROGRAM,  
12 THE EMPLOYEE IS EXPECTED TO OBTAIN FULL-TIME EMPLOYMENT IN AN  
13 OCCUPATION IDENTIFIED AS A TOP JOB IN THE ANNUAL COLORADO TALENT  
14 REPORT PREPARED BY THE STATE WORKFORCE DEVELOPMENT COUNCIL  
15 PURSUANT TO SECTION 24-46.3-103 (3), C.R.S."

16 Page 6, line 24, strike "REVENUES" and substitute "REVENUE IN GRANTS".

17 Page 7, line 4, strike "LOW-WAGE" and substitute "COVERED".

18 Page 9, line 7, strike "LARGE BUSINESSES" and substitute "COVERED  
19 EMPLOYERS".

20 Page 9, line 11, after "BY" insert "COVERED".

21 Page 10, after line 4 insert:

22 "(i) TO UNILATERALLY REQUIRE OR WORK IN CONJUNCTION WITH  
23 THE DEPARTMENT OF LABOR AND EMPLOYMENT TO REQUIRE COVERED  
24 EMPLOYERS TO FURNISH ANY INFORMATION AND REPORTS NEEDED FOR  
25 THE IMPLEMENTATION AND ENFORCEMENT OF THIS PART 6;".

26 Reletter succeeding paragraphs accordingly.

27 Page 11, line 2, strike "2017," and substitute "2018,".

28 Page 11, line 5, strike "LOW-WAGE EMPLOYER THAT".

29 Page 11, strike line 6 and substitute "COVERED EMPLOYER. THE".

30 Page 11, line 13, strike "SUCH AN EMPLOYER. AN" and substitute "A  
31 COVERED EMPLOYER. A COVERED".

- 1 Page 11, line 17, strike "LOW-WAGE" and substitute "COVERED".
- 2 Page 11, line 25, strike "THE" and substitute "SUBJECT TO ANNUAL
- 3 APPROPRIATION BY THE ENTERPRISE, THE".
- 4 Page 12, strike lines 4 and 5 and substitute "PART 6."
- 5 Page 12, line 7, strike the first "LOW-WAGE" and substitute "COVERED"
- 6 and strike the second "LOW-WAGE" and substitute "COVERED".
- 7 Page 12, line 11, before "EMPLOYER" insert "COVERED".
- 8 Page 12, line 15, strike "LOW-WAGE" and substitute "COVERED".
- 9 Page 12, line 16, before "EMPLOYER" insert "COVERED".
- 10 Page 12, line 18, strike "LOW-WAGE" and substitute "COVERED".
- 11 Page 12, line 21, strike "LOW-WAGE" and substitute "COVERED".
- 12 Page 1, line 104, strike "LOW-WAGE" and substitute "COVERED".
- 13 Page 1, line 110, strike "LOW-WAGE" and substitute "COVERED".
