HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.HB17-1303 be amended as follows:

1 Amend proposed committee amendment (HB1303_L.001), page 1, line
2 23, after "APPOINTMENT" insert "TO A DISTRICT COMMISSION".

3 Page 1, line 25, strike "ONE ATTORNEY AND" and after "APPOINTMENTS"
4 insert "TO A DISTRICT COMMISSION".

5 Page 1, line 35, strike "EACH" and substitute "THE STATE" and strike
6 "TEN" and substitute "ELEVEN".

7 Page 2, line 3, strike "ONE ATTORNEY AND".

8 Page 2, line 6, strike "ONE".

9 Page 2, strike lines 7 and 8 and substitute "ONE NONATTORNEY;
10 (V) THE CHIEF JUSTICE OF THE SUPREME COURT SHALL APPOINT
11 TWO ATTORNEYS; AND

12 (VI) THE GOVERNOR SHALL APPOINT TWO NONATTORNEYS AND
13 ONE ATTORNEY.".

14 Page 2, strike lines 9 through 13 and substitute:

15 "(b) THE TERMS OF STATE COMMISSIONERS APPOINTED PRIOR TO
16 JANUARY 31, 2019, SHALL CONTINUE UNTIL SUCH TIME AS HIS OR HER
17 TERM WAS ORIGINALLY SET TO EXPIRE; EXCEPT THAT THE TERM OF THE
18 NONATTORNEY APPOINTED BY THE CHIEF JUSTICE OF THE SUPREME COURT
19 PURSUANT TO SUBSECTION (2)(a)(IV) OF THIS SECTION EXPIRES ON
20 JANUARY 31, 2019.".

21 Page 2, after line 14 insert:

22 "(4) (a) EACH DISTRICT COMMISSION CONSISTS OF TEN MEMBERS,
23 APPOINTED ON OR BEFORE MARCH 1, 2019, AS FOLLOWS:

24 (I) THE SPEAKER OF THE HOUSE OF REPRESENTATIVES SHALL
25 APPOINT ONE ATTORNEY AND ONE NONATTORNEY;

26 (II) THE PRESIDENT OF THE SENATE SHALL APPOINT ONE ATTORNEY
27 AND ONE NONATTORNEY;

28 (III) THE MINORITY LEADER OF THE HOUSE OF REPRESENTATIVES
29 SHALL APPOINT ONE NONATTORNEY;

30 (IV) THE MINORITY LEADER OF THE SENATE SHALL APPOINT ONE
31 NONATTORNEY;



1 (V) THE CHIEF JUSTICE OF THE SUPREME COURT SHALL APPOINT
2 TWO ATTORNEYS; AND

3 (VI) THE GOVERNOR SHALL APPOINT TWO NONATTORNEYS.

4 (b) THE TERMS OF DISTRICT COMMISSIONERS APPOINTED PRIOR TO
5 JANUARY 31, 2019, SHALL CONTINUE UNTIL SUCH TIME AS HIS OR HER
6 TERM WAS ORIGINALLY SET TO EXPIRE; EXCEPT THAT THE FOLLOWING
7 COMMISSIONERS' TERMS EXPIRE ON JANUARY 31, 2019:

8 (I) THE NONATTORNEY APPOINTED BY THE CHIEF JUSTICE OF THE
9 SUPREME COURT PURSUANT TO SUBSECTION (2)(a)(IV) OF THIS SECTION;
10 AND

11 (II) THE ATTORNEY APPOINTED BY THE GOVERNOR PURSUANT TO
12 SUBSECTION (2)(a)(III) OF THIS SECTION.

13 (c) THIS SUBSECTION (4) BECOMES EFFECTIVE FEBRUARY 1,
14 2019."

15 Renumber succeeding subsections accordingly.
