HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

HB20-1278 be amended as follows:

- 1 Amend printed bill, page 4, strike lines 22 through 24 and substitute
- 2 "PENALTY OF PERJURY PURSUANT TO SECTION 18-8-503."

- 3 Page 7, line 27, strike "ARREST OR SEARCH" and substitute "ARREST."

- 4 Page 8, strike line 1.

- 5 Page 11, strike lines 25 through 27 and substitute:
- 6 "(d) IF A SHERIFF OR LAW ENFORCEMENT AGENCY HAS PROBABLE
- 7 CAUSE TO BELIEVE A FIREARM LISTED IN THE FIREARM INFORMATION FORM
- 8 DESCRIBED IN SUBSECTION (2)(a)(II) OF THIS SECTION HAS BEEN USED IN
- 9 THE COMMISSION OF A CRIME, IS STOLEN, OR IS CONTRABAND, THE SHERIFF
- 10 OR LAW ENFORCEMENT AGENCY THAT ELECTS TO STORE THE FIREARM
- 11 SHALL OBTAIN A SEARCH WARRANT BEFORE ACCEPTING THE FIREARM AS
- 12 EVIDENCE, EXAMINING OR TESTING THE FIREARM, OR FACILITATING A
- 13 CRIMINAL INVESTIGATION OF THE CRIME."

- 14 Page 12, strike lines 1 through 6.

- 15 Page 15, strike lines 25 through 27 and substitute "PERJURY PURSUANT TO
- 16 SECTION 18-8-503."

- 17 Page 22, strike lines 19 through 27 and substitute:
- 18 "(IV) IF A SHERIFF OR LAW ENFORCEMENT AGENCY HAS PROBABLE
- 19 CAUSE TO BELIEVE A FIREARM LISTED IN THE FIREARM INFORMATION FORM
- 20 DESCRIBED IN SUBSECTION (9)(b)(I)(B) OF THIS SECTION HAS BEEN USED
- 21 IN THE COMMISSION OF A CRIME, IS STOLEN, OR IS CONTRABAND, THE
- 22 SHERIFF OR LAW ENFORCEMENT AGENCY THAT ELECTS TO STORE THE
- 23 FIREARM SHALL OBTAIN A SEARCH WARRANT BEFORE ACCEPTING THE
- 24 FIREARM AS EVIDENCE, EXAMINING OR TESTING THE FIREARM, OR
- 25 FACILITATING A CRIMINAL INVESTIGATION OF THE CRIME."
