- 19 "(b) PRIOR TO SEEKING FEDERAL APPROVAL PURSUANT TO
20 SUBSECTION (2)(a) OF THIS SECTION, THE STATE DEPARTMENT SHALL SEEK
21 INPUT FROM RELEVANT STAKEHOLDERS, INCLUDING EXISTING PROVIDERS
22 OF SUBSTANCE USE DISORDER TREATMENT AND MEDICAL DETOXIFICATION
23 SERVICES AND MANAGED SERVICE ORGANIZATIONS. THE STATE
24 DEPARTMENT SHALL SEEK INPUT AND INVOLVE STAKEHOLDERS IN
25 DECISIONS REGARDING:
- 26 (I) THE COORDINATION OF BENEFITS WITH MANAGED SERVICE
27 ORGANIZATIONS AND THE OFFICE OF BEHAVIORAL HEALTH IN THE
28 DEPARTMENT OF HUMAN SERVICES;
- 29 (II) THE MOST APPROPRIATE ENTITY FOR ADMINISTRATION OF THE
30 BENEFIT;
- 31 (III) THE PROVISION OF WRAPAROUND SERVICES NEEDED DURING

1 TREATMENT AND THE PROVISION OF REQUIRED SERVICES FOLLOWING
2 TREATMENT THAT MAY NOT BE COVERED THROUGH THE MEDICAL
3 ASSISTANCE PROGRAM;

4 (IV) THE AUTHORIZATION PROCESS FOR APPROVAL OF SERVICES;
5 AND

6 (V) THE DEVELOPMENT OF A REIMBURSEMENT RATE
7 METHODOLOGY TO ENSURE SUSTAINABILITY THAT CONSIDERS A
8 PROVIDER'S COST OF PROVIDING CARE INCLUDING LOWER-VOLUME
9 PROVIDERS IN RURAL AREAS."

10 Page 4, line 4, after "TREATMENT" insert "AND MEDICAL DETOXIFICATION
11 SERVICES".

12 Page 4, line 6, strike "REPRIORITIZE THE USE OF" and substitute
13 "DETERMINE TO WHAT EXTENT".

14 Page 4, line 7, after "FUND" insert "MAY BE USED".

15 Page 4, lines 9 and 10, strike "TREATMENT, TO PERSONS WHO" and
16 substitute "TREATMENT AND MEDICAL DETOXIFICATION SERVICES, IF
17 THOSE SERVICES".
