HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public Health Care & Human Services.

HB18-1136 be amended as follows:

1 Amend printed bill, page 2, line 5, strike "**services.**" and substitute
2 "**services - repeal.**".

3 Page 2, after line 15 insert:

4 "(III) THIS SUBSECTION (1)(x) IS REPEALED, EFFECTIVE JULY 1,
5 2022."

6 Page 2, line 19, strike "**approval.**" and substitute "**approval - repeal.**".

7 Page 3, after line 15 insert:

8 "(3) (a) NO LATER THAN JANUARY 15, 2022, THE STATE
9 DEPARTMENT SHALL PREPARE AND SUBMIT A REPORT TO THE JOINT
10 BUDGET COMMITTEE AND TO THE JOINT HEALTH AND HUMAN SERVICES
11 COMMITTEE, OR ANY SUCCESSOR COMMITTEES, CONCERNING THE
12 RESIDENTIAL AND INPATIENT SUBSTANCE USE DISORDER TREATMENT
13 PURSUANT TO THIS SECTION, INCLUDING, AT A MINIMUM:

14 (I) THE NUMBER OF PERSONS WHO RECEIVED SERVICES PURSUANT
15 TO THIS SECTION AND THE SERVICE PROVIDED;

16 (II) THE LENGTH OF TIME THAT SERVICES WERE PROVIDED;

17 (III) THE LOCATION WHERE SERVICES WERE PROVIDED;

18 (IV) THE EFFECTIVENESS OF THE SERVICES PROVIDED, INCLUDING
19 THE RATE OF RELAPSE TO SUBSTANCE USE DISORDER FOLLOWING
20 TREATMENT; AND

21 (V) ANY OTHER INFORMATION AS DETERMINED BY THE STATE
22 DEPARTMENT THAT IS RELEVANT TO THE BENEFIT.

23 (b) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2022.

24 (4) IN ANY FISCAL YEAR IN WHICH THE TOTAL AMOUNT OF
25 GENERAL FUND RESOURCES NECESSARY FOR THE STATE'S SHARE OF
26 FUNDING FOR THE MEDICAL ASSISTANCE PROGRAM EXCEEDS THE AMOUNT
27 OF GENERAL FUND RESOURCES NECESSARY FOR THE STATE'S SHARE OF
28 FUNDING FOR THE MEDICAL ASSISTANCE PROGRAM FOR THE 2018-19
29 FISCAL YEAR, THE GENERAL ASSEMBLY SHALL REVIEW THE LEGISLATION
30 ENACTING THE OPTIONAL SERVICES AND POPULATIONS SERVED UNDER THE
31 MEDICAL ASSISTANCE PROGRAM TO PRIORITIZE AND ALLOCATE FUNDING
32 FOR THESE SERVICES AND POPULATIONS IN ORDER TO MAINTAIN THE LEVEL
33 OF GENERAL FUND RESOURCES SPENT ON THE MEDICAL ASSISTANCE
34 PROGRAM FOR THE 2018-19 FISCAL YEAR."
