SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.SB16-188 be amended as follows:

1 Amend printed bill, page 5, after line 19 insert:

2 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
3 CONTRARY, AS A CONDITION OF RECEIVING A PORTION OF THE ADDITIONAL
4 MILL LEVY REVENUE PURSUANT TO THIS SECTION, A CHARTER SCHOOL
5 SHALL NOT INVOKE ANY OF THE AUTOMATIC WAIVERS OF STATUTE AND
6 RULE IDENTIFIED BY THE STATE BOARD PURSUANT TO SECTION
7 22-30.5-104. A CHARTER SCHOOL MAY SEEK A WAIVER OF ONE OR MORE
8 OF THE STATUTES INCLUDED ON THE LIST OF AUTOMATIC WAIVERS IN THE
9 SAME MANNER IN WHICH IT MAY SEEK A WAIVER OF ANOTHER STATUTE;
10 EXCEPT THAT THE STATE BOARD SHALL NOT WAIVE A STATUTE FOR A
11 CHARTER SCHOOL IF WAIVER OF THE STATUTE IS PROHIBITED FOR A
12 SCHOOL DISTRICT AS PROVIDED IN SECTION 22-2-117."

13 Page 10, after line 18, insert:

14 "(3) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
15 CONTRARY, AS A CONDITION OF RECEIVING A MILL LEVY EQUALIZATION
16 PAYMENT PURSUANT TO THIS SECTION, AN INSTITUTE CHARTER SCHOOL
17 SHALL NOT INVOKE ANY OF THE AUTOMATIC WAIVERS OF STATUTE AND
18 RULE IDENTIFIED BY THE STATE BOARD PURSUANT TO SECTION
19 22-30.5-104. AN INSTITUTE CHARTER SCHOOL MAY SEEK A WAIVER OF ONE
20 OR MORE OF THE STATUTES INCLUDED ON THE LIST OF AUTOMATIC
21 WAIVERS IN THE SAME MANNER IN WHICH IT MAY SEEK A WAIVER OF
22 ANOTHER STATUTE; EXCEPT THAT THE STATE BOARD SHALL NOT WAIVE A
23 STATUTE FOR AN INSTITUTE CHARTER SCHOOL IF WAIVER OF THE STATUTE
24 IS PROHIBITED FOR A SCHOOL DISTRICT AS PROVIDED IN SECTION
25 22-2-117."
