SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB22-087 be amended as follows:

1 Amend corrected printed bill, page 6, after line 10, insert:

2 "(12) "RURAL SCHOOL DISTRICT" MEANS A SCHOOL DISTRICT IN  
3 COLORADO THAT THE DEPARTMENT OF EDUCATION DETERMINES IS RURAL,  
4 BASED ON THE GEOGRAPHIC SIZE OF THE SCHOOL DISTRICT AND THE  
5 DISTANCE OF THE SCHOOL DISTRICT FROM THE NEAREST LARGE,  
6 URBANIZED AREA."

7 Renumber succeeding subsections accordingly.

8 Page 10, line 8, strike "(2)(b)" and substitute "(2)(c)".

9 Page 10, strike line 13 and substitute "DOLLARS OR:

10 (I) FOR SCHOOL FOOD AUTHORITIES THAT ARE RURAL SCHOOL  
11 DISTRICTS AND OTHER SCHOOL FOOD AUTHORITIES THAT HAVE AN  
12 IDENTIFIED STUDENT PERCENTAGE OF FIFTY PERCENT OR HIGHER, AN  
13 AMOUNT EQUAL TO TWENTY CENTS MULTIPLIED BY".

14 Page 10, strike line 16 and substitute "PRECEDING SCHOOL YEAR;

15 (II) FOR SCHOOL FOOD AUTHORITIES THAT ARE NOT RURAL SCHOOL  
16 DISTRICTS AND HAVE AN IDENTIFIED STUDENT PERCENTAGE OF AT LEAST  
17 TWENTY PERCENT BUT LESS THAN FIFTY PERCENT, AN AMOUNT EQUAL TO  
18 TEN CENTS MULTIPLIED BY THE NUMBER OF LUNCHES THAT QUALIFIED AS  
19 AN ELIGIBLE MEAL THAT THE PARTICIPATING SCHOOL FOOD AUTHORITY  
20 SERVED TO STUDENTS IN THE PRECEDING SCHOOL YEAR; AND

21 (III) FOR SCHOOL FOOD AUTHORITIES THAT ARE NOT RURAL  
22 SCHOOL DISTRICTS AND HAVE AN IDENTIFIED STUDENT PERCENTAGE THAT  
23 IS LESS THAN TWENTY PERCENT, AN AMOUNT EQUAL TO FIVE CENTS  
24 MULTIPLIED BY THE NUMBER OF LUNCHES THAT QUALIFIED AS AN ELIGIBLE  
25 MEAL THAT THE PARTICIPATING SCHOOL FOOD AUTHORITY SERVED TO  
26 STUDENTS IN THE PRECEDING SCHOOL YEAR.

27 (b) A PARTICIPATING SCHOOL FOOD AUTHORITY".

28 Reletter succeeding paragraph accordingly.

29 Page 11, line 12, strike "(2)(b)." and substitute "(2)(c)".

30 Page 13, line 2, strike "TWELVE" and substitute "SIX".

31 Page 17, line 2, strike "FIVE MILLION" and substitute "TWO MILLION FIVE  
32 HUNDRED THOUSAND".
