SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB16-019 be amended as follows:

1 Amend proposed committee amendment (SB019_L.001), page 1, line 2,
2 strike "WITH THE" and substitute "WITH A PSYCHIATRIST OR FORENSIC
3 PSYCHOLOGIST MAY".

4 Page 1, line 3, strike "MENTAL HEALTH PROFESSIONAL WILL".

5 Page 1, strike lines 10 through 13 and substitute "EQUIPMENT WITH THE
6 COURT, WHICH MAY CONSULT WITH THE DISTRICT ATTORNEY AND DEFENSE
7 COUNSEL FOR AN AGREED UPON LOCATION. IF NO AGREEMENT IS REACHED,
8 AND UPON THE REQUEST OF EITHER THE DEFENSE COUNSEL OR DISTRICT
9 ATTORNEY, THE COURT SHALL ORDER THE LOCATION OF THE EXAMINATION
10 WHICH MAY INCLUDE THE COLORADO MENTAL HEALTH INSTITUTE AT
11 PUEBLO."

12 Page 1, strike lines 27 through 33 and substitute:

13 "(d) THE COURT SHALL DETERMINE THE ADMISSIBILITY OF ANY
14 RECORDING OR PARTIAL RECORDING, IN WHOLE OR IN PART, SUBJECT TO
15 ALL AVAILABLE CONSTITUTIONAL AND EVIDENTIARY OBJECTIONS."."

16 Page 2, line 1, strike "WITH THE MENTAL HEALTH" and substitute "WITH
17 A PSYCHIATRIST OR FORENSIC PSYCHOLOGIST MAY".

18 Page 2, line 2, strike "PROFESSIONAL WILL".

19 Page 2, strike lines 9 through 12 and substitute "EQUIPMENT WITH THE
20 COURT, WHICH MAY CONSULT WITH THE DISTRICT ATTORNEY AND DEFENSE
21 COUNSEL FOR AN AGREED UPON LOCATION. IF NO AGREEMENT IS REACHED,
22 AND UPON THE REQUEST OF EITHER THE DEFENSE COUNSEL OR DISTRICT
23 ATTORNEY, THE COURT SHALL ORDER THE LOCATION OF THE EXAMINATION
24 WHICH MAY INCLUDE THE COLORADO MENTAL HEALTH INSTITUTE AT
25 PUEBLO."

26 Page 2, strike lines 26 through 32 and substitute:

27 "(c) THE COURT SHALL DETERMINE THE ADMISSIBILITY OF ANY
28 RECORDING OR PARTIAL RECORDING, IN WHOLE OR IN PART, SUBJECT TO
29 ALL AVAILABLE CONSTITUTIONAL AND EVIDENTIARY OBJECTIONS."."
