

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

SB22-145 be amended as follows:

- 1 Amend printed bill, page 6, line 17, after the period insert "THE DIRECTOR
- 2 SHALL ENSURE THAT THE COMPOSITION OF THE COMMITTEE IS RACIALLY,
- 3 ETHNICALLY, AND GEOGRAPHICALLY DIVERSE AND REPRESENTATIVE OF
- 4 THE COMMUNITIES WHERE CRIME IS DISPROPORTIONATELY HIGH."

- 5 Page 6, line 18, strike "ELEVEN" and substitute "THIRTEEN".

- 6 Page 6, line 26, strike "POLICY;" and substitute "POLICY AND RESEARCH
- 7 OR EVALUATION OF EFFECTIVE COMMUNITY-BASED SERVICES THAT
- 8 REDUCE CRIME AND VIOLENCE;".

- 9 Page 7, before line 7, insert:
- 10 (E) A MEMBER WHO REPRESENTS A FEDERALLY RECOGNIZED TRIBE
- 11 WITH JURISDICTION IN COLORADO;"

- 12 Reletter succeeding sub-subparagraphs accordingly.

- 13 Page 7, strike line 8 and substitute "13-90-107 (1)(k)(II), WITH
- 14 EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE SERVICES IN
- 15 COMMUNITIES OF COLOR OR A REPRESENTATIVE FROM A
- 16 COMMUNITY-BASED VICTIM SERVICES ORGANIZATION THAT SPECIALIZES
- 17 IN SERVING VICTIMS OF COLOR;"

- 18 Page 7, line 10, strike "HEALTH-CARE;" and substitute "HEALTH CARE
- 19 WITH EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE CARE IN
- 20 COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;"

- 21 Page 7, strike line 12, and substitute "SPECIALIZING IN DIVERTING
- 22 INDIVIDUALS FROM THE CRIMINAL JUSTICE SYSTEM WITH EXPERIENCE IN
- 23 PROVIDING CULTURALLY RESPONSIVE SERVICES IN COMMUNITIES OF
- 24 COLOR AND UNDERSERVED POPULATIONS;"

- 25 Page 7, strike lines 13 and 14.

- 26 Page 7, strike line 15 and substitute:
- 27 "(I) A MEMBER WHO SPECIALIZES IN VIOLENCE PREVENTION,
- 28 INCLUDING IN COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;
- 29 AND
- 30 (J) A COMMUNITY REPRESENTATIVE."
