SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

SB22-145 be amended as follows:

- 1 Amend printed bill, page 12, line 2, strike "APPLICATIONS" and substitute
2 "APPLICATIONS, PERFORMANCE METRICS THAT GRANTEES WILL BE
3 EXPECTED TO PROVIDE, DATA AND OTHER RELEVANT INFORMATION
4 REQUIRED AS PART OF THEIR GRANT REPORT DESCRIBED IN SUBSECTION (5)
5 OF THIS SECTION,".

- 6 Page 12, line 16, strike "AND".

- 7 Page 12, line 22, strike "TRAINER." and substitute "TRAINER; AND
8 (d) DEVELOP GOALS FOR FOSTERING BETTER RELATIONSHIPS
9 BETWEEN LAW ENFORCEMENT AND IMPACTED COMMUNITIES.".

- 10 Page 12, line 25, after the period insert "THE EXECUTIVE DIRECTOR SHALL
11 ENSURE THAT THE COMPOSITION OF THE COMMITTEE IS RACIALLY,
12 ETHNICALLY, AND GEOGRAPHICALLY DIVERSE AND REPRESENTATIVE OF
13 THE COMMUNITIES WHERE CRIME IS DISPROPORTIONATELY HIGH." and
14 strike "TEN" and substitute "TWELVE".

- 15 Page 13, line 11, strike "ISSUES;" and substitute "ISSUES, WITH
16 EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE CARE IN
17 COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;".

- 18 Page 13, line 13, strike "13-90-107 (1)(k)(II);" and substitute "13-90-107
19 (1)(k)(II), WITH EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE
20 SERVICES IN COMMUNITIES OF COLOR, OR A REPRESENTATIVE FROM A
21 COMMUNITY-BASED VICTIM SERVICES ORGANIZATION THAT SPECIALIZES
22 IN SERVING VICTIMS OF COLOR;".

- 23 Page 13, line 18, strike "AND".

- 24 Page 13, after line 20 insert:
25 "(H) A REPRESENTATIVE OF A FEDERALLY RECOGNIZED TRIBE WITH
26 JURISDICTION IN COLORADO; AND
27 (I) A REPRESENTATIVE FROM THE COLORADO COMMUNITY
28 COLLEGE SYSTEM;".
